Where To Use Surface Preparation: Surfaces must be clean, dry and dull prior to application. Thoroughly clean the surface and allow to dry. Can be used as full interior primer or exterior spot primer for Remove wallpaper and loose, peeling paint. Scrape and sand properly prepared interior and exterior drywall, plaster and wood. peeled or damaged paint. Sand glossy surfaces dull. All dust Do not thin. should be removed. Drywall: Fill cracks and holes with joint compound and sand smooth. Plaster: Must be dry, fully cured and in good condition. Remove all chalky residue. Wood: Sand to a fresh surface. Patch imperfections with wood filler. If the stain bleeds through, apply a second coat of primer and allow to dry overnight Finish: Flat and retest before topcoating. When spot priming on some surfaces, a non-uniform appearance of the final coat may result, Flash Point: 55°F PMCC due to differences in holdout between primed and unprimed areas. To avoid this, prime the entire surface rather than spot Weight Solids: 61 ± 2% priming. See technical data page for additional surface prep. **Volume Solids:** 35 ± 2% Clean Mildew From the Surface: Mildew is a fungus that looks like dirt, but won't washoff. Weight per gallon: 11.02 lbs Mildew must be removed before painting or it will grow through any new coat of paint. To remove mildew or suspected mildew, VOC: 516 grams per litre; 4.30 lbs. per scrub surface before painting with a commercial mildew remover gallon as per 40 CFR 59.406 or a solution of 1 part liquid chlorine bleach to 3 parts water. Rinse thoroughly. Avoid contact with skin and eyes. Protect skin Film Thickness: 4 mils wet; 1.4 mils dry and eyes by wearing rubbergloves and eye goggles when working with bleach solution. Application

Application: Stir primer thoroughly before and during use. Apply with a natural bristle brush, pad applicator, synethic roller or airless sprayer. If applying by sprayer, back-roll or back-brush to work primer into the surface. Apply a liberal coat of primer uniformly, working well into the surface.

Clean Up/Disposal

Cleanup/Disposal: Clean brushes and tools with a VOC compliant solvent-based brush and tool cleaner following manufacturer's safety instructions. Wash hands with soap and water. Do not pour unused contents down the drain. Consult with local authorities for proper method of disposal and recycling.
