### Section 4. First aid measures

#### **Description of necessary first aid measures** Eye contact : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Inhalation : Remove victim to fresh air and keep at rest in a position comfortable for breathing. 
