# Section 4. First aid measures

## **Description of necessary first aid measures**

**Eye contact** 

: Get medical attention immediately. Call a poison center or physician. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. # Section 6. Accidental release measures

## Personal precautions, protective equipment and emergency procedures

# For non-emergency personnel

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering.
