DESCRIPTION

Recommended Uses:

Cabot Wood Brightener Concentrate #8003 is a concentrate specifically formulated to remove unsightly discoloration of wood caused by tannin bleed in extractive-prone wood species such as cedar and redwood. It also removes nail and metal rust stains. Cabot Wood Brightener is ideal for use on new or previously stained, painted or unfinished wood surfaces including decks, siding, fences, railings and steps. Plus, when used on weathered wood, Cabot Problem-Solver Wood Brightener renews the rich "new wood" look.

Composition:

Contains the concentrated brightener agent, oxalic acid.

Appearance:

Clear blue liquid.

VOC: < 5%

Coverage:

One gallon of diluted Cabot Wood Brightener Concentrate will clean approximately 200-250 square feet. These rates will vary depending on the porosity of the surface.

Packaging/Containers:

Concentrate is available in one-gallon containers.

Restrictions:

Never mix or use with other chemicals, detergents, cleaners or with Cabot Wood Cleaner. To do so may result in rapid release of hazardous gases. Keep containers closed when not in use. Keep away from children, animals and vegetation. Prolonged contact with metal may cause pitting.

Environmental Impact:

Protect any nearby plants, shrubs or other vegetation by wetting them down with water and covering them with plastic before application. Hose off shrubs when job is done.

Cleanup and Disposal: Rinse out container and application equipment thoroughly with water. Do not reuse container. Dispose of in accordance with local, state and federal regulations. Material Safety Data Sheet (MSDS) available upon request.

Flash Point: None. This product is not flammable.

Shelf Life: For best results, this product should be used as soon as possible after recommended dilution with water.

APPLICATION

Surface Preparation:

APPLY LIBERALLY to problem surfaces using a brush or pump sprayer. Do not apply to hot surfaces. To avoid nonuniform appearances on vertical surfaces, start at the bottom doing a small section at a time and continue to the top. LET SET 15-20 MINUTES. Stubborn areas may require scrubbing with a stiff bristle brush. If surface begins to dry quickly, lightly mist with water. RINSE THOROUGHLY using a garden hose with nozzle at maximum pressure or a high-pressure power washer. Repeat procedure if necessary. IMPORTANT: Allow cleaned surfaces to dry completely before staining or painting. Do not apply this product when temperature is below 50°F (10°C). IMPORTANT: Always wear safety goggles or a face shield, rubber gloves, protective clothing and footwear when spraying. IMPORTANT: When applying and rinsing product, walking surfaces, ladders and scaffolding may become slippery. Rinse all such surfaces thoroughly to remove overspray
