<u>APPLICATION</u>

Application: APPLY LIBERALLY to surface using a brush or pump sprayer. Do not apply to hot or wet surfaces. Let stand for 15 minutes. Do not allow to dry. RINSE using a garden hose with nozzle at maximum pressure or use a pressurewashing unit. Do not exceed 1000 PSI. After rinsing, neutralize with Valspar All-in-One Prep. IMPORTANT: All surfaces must be thoroughly neutralized with Valspar All-in-One Wood Prep. rinsed and dried a minimum of 2 days, depending on temperature and humidity prior to recoating. Any stripper not rinsed from the surface will cause coating adhesion problems. IMPORTANT: USE EXTREME CAUTION WHEN WORKING ON THE SURFACE TO BE STRIPPED. Wait 2-3 days, depending on weather conditions, for the wood to dry thoroughly before applying an oil-based waterproofer or stain. Use Valspar® Exterior Stain & Sealers to protect your wood from the elements and provide the highest level of waterproofing protection available.
