## APPLICATION AND CLEANUP

Mix well before and during use. If using more than one container, intermix all cans of the same color. Use a premium-quality, polyester brush for small area (stairs, etc.). For large areas, pour Valspar® Anti-Skid Porch and Floor Paint coating in a long, continuous bead across the "shorter side" of the surface. Spread the product uniformly with a premium-quality, 1/4" or 3/8" nap roller and finish with long, even strokes in one direction. After drying 24 hours, apply the second coat if necessary or desired, at a right angle to the first coat — again finishing with long, even strokes in one direction. Clean tools and hands with warm, soapy water. Discard used roller covers. Do not allow water to pond or puddle on newly painted surfaces.

## SURFACE PREPARATION

#### General:

Read the Lead Warning paragraph. The surface must be clean, dry and free of all loose or peeling paint. Thoroughly clean surface and remove wax and grease with an all-purpose cleaner (TSP or substitute). Clean joints and cracks to remove all foreign material. Patch voids with appropriate crack patching material. Areas where ponding water is evident should be leveled prior to application. Although not required, a coat of Concrete Primer prior to application of Anti-Skid Porch and Floor Paint coats will increase the adhesion to these properly prepared surfaces.

#### Concrete:

New concrete, masonry surfaces and mortar should be cured 60 days. Remove all form release or curing agents. New, unpainted or smooth-worn concrete must be etched with a concrete cleaner, degreaser and etcher for proper penetration and adhesion. Follow all label instructions. Remove all loose material or dust. Soft concrete or masonry surfaces should be primed with a Valspar® Exterior Latex Primer.

#### Etching:

New, unpainted or smooth-worn concrete must be etched with a muriatic acid solution for proper penetration and adhesion. Before preparing acid solution, READ ALL CAUTIONS AND WARNINGS on acid packaging. Wear appropriate protective clothing, goggles and rubber gloves when handling acid. Mix 1 quart of muriatic acid and 1 gallon of water. Flush floor with acid solution. DO NOT BREATHE VAPORS and make certain there is good ventilation. After 30 minutes, or when acid solution stops bubbling, rinse with water while scrubbing the floor with a stiff broom to remove all powdery residue. Allow to dry. Properly etched concrete will feel like rough sandpaper.

#### Asphalt:

New asphalt should be weathered 4 to 6 months prior to application. Do not apply over shiny asphalt or freshly applied tar emulsion driveway sealers.

#### Bare Wood:

Remove sap from knots and sappy areas. Spot prime then prime entire area with appropriate Valspar® Exterior Latex or Oil-Based Primer.

#### SURFACE PREP CONTINUED

#### Metal:

Hand or power tool clean steel to remove loose mill scale and rust. Remove oily residues and contaminants with solvent or appropriate cleaning solution. Change rags often, to assure that residual contaminants are completely removed. Prime with Valspar® Armor Anti-Rust Primer.
