SURFACE PREPARATION

Plaster:

Allow new plaster to fully cure and sand smooth. Remove all sanding dust. New plaster must be primed with a Valspar[®] Interior Latex Primer.

Wood:

Sand wood smooth and patch holes and imperfections with wood filler or putty and sand smooth. Remove all sanding dust. New or bare surfaces must be primed with an appropriate Valspar[®] primer.

Concrete/Masonry:

New concrete, masonry surfaces and mortar should be cured, usually 30 days. Remove all form release or curing agents. Remove all loose material or dust. Soft concrete or masonry surfaces should be primed with a Valspar[®] Latex Primer.
