#### SURFACE PREPARATION

Bare concrete: Allow 60 days minimum for new concrete to cure before sealing. Clean and etch new or bare concrete with Valspar® Fast Prep® Cleaner, Degreaser & Etcher. Follow all Fast Prep label instructions.

Previously painted/Stained concrete: Strip off all old coating and then follow bare concrete instructions.

#### APPLICATION AND CLEANUP

Mix well before and during use. Intermix cans of the same color. Apply with a high-quality, polyester brush or 1/4" or 3/8" nap roller. Spread product evenly and finish with long, even strokes in the same direction. Two coats are recommended for most applications (wait 24 hours for second coat). Clean up with warm, soapy water.
