Previously Painted Surfaces: Thoroughly clean the surface and allow to dry. Remove all dirt, dust, chalk, rust, grease, wax and mildew. Scrape off loose and peeling paint. Dull glossy surfaces by sanding

Bare Wood, Plywood/Composition Board: For best results over heavily stained areas and bleeding woods such as redwood and cedar, use a coat of stain-blocking primer.

Metal: Remove rust on galvanized surfaces and prime with a rust-inhibitive metal primer. For drastic color changes or deep, vivid colors, prime with this product or an appropriate tintable primer for your optimal color accuracy and coverage.
